Our Purpose & Mission

01 Company Purpose

The Tuscarawas County Committee on Aging, Inc., doing business as the Tuscarawas County Senior Center, was incorporated in 1979 and operates as a tax-exempt nonprofit organization under IRS Section 501(c)(3). The Senior Center serves as a vital resource and trusted community hub for adults age 50 and older living in Tuscarawas County.

As one of the few organizations in the region dedicated exclusively to the needs of older adults, the Center provides a broad range of programs and services that support health, independence, and social engagement. Each day, an average of 300 seniors utilize the Center to participate in activities such as congregate meals, exercise and wellness classes, educational presentations, club meetings, recreational trips, medical screenings, transportation and Medicare consultations.

To support these essential programs, the Tuscarawas County Senior Center employs an annual workforce of approximately 70 to 80 staff members, who are committed to enhancing the quality of life for the county's aging population.

Operational Highlights 2025

June 6 Celebration

The Tuscarawas County Senior Center relocated to its current Prospect Street facility in June 2005. Under the leadership of Executive Director Phyllis Karling, the move reflected her forward-thinking vision to create a space designed specifically to meet the evolving needs of the county's aging population. Her dedication resulted in a welcoming, vibrant environment where seniors could enjoy nutritious meals, participate in fitness and wellness activities, and build meaningful social connections.

In 2025, the organization proudly celebrated 20 years on Prospect Street, marking the milestone with a daylong celebration featuring music, food, games, and a photo booth. Today, the facility remains a central gathering place for our 50 North population—a place where older adults can stay active, engage in educational programs, enjoy meals in the dining room, or relax with friends at Prospect Perks Coffee & Café.

The Center continues to honor its legacy while looking toward the future, remaining committed to supporting the health, independence, and well-being of seniors throughout Tuscarawas County.

Tusky Valley Senior Center

On February 4, 2025, the Tusky Valley Senior Center opened in the former Tusky Valley High School, now home to several local nonprofits and medical providers. Led by Center Manager Nancy Raber, the new location saw strong community enthusiasm, with more than 300 individuals becoming members in its first month.



Operational Highlights 2025

Forks Corks & Comedy

The 3rd Annual Forks, Corks & Comedy event was held on Monday, October 27, 2025, featuring an exceptional lineup of local celebrity chefs: David Case (Point Dining), Jill Cunningham (Tuscarawas County Senior Center), Nathan Kelly (63 Corks), and David Webb (Union Country Club). Comedy entertainment was provided by Dan Brown and Mike Conley, adding energy and excitement to the evening.

Forks, Corks & Comedy is more than a fundraiser—it is a lifeline for the seniors we serve. While levy support covers approximately 54% of our operating costs, we must raise the remaining 46% to sustain the essential programs and services our older adults rely on every day. These funds help provide meals that nourish, transportation that keeps seniors connected, and the sense of companionship that ensures no one feels alone. Every dollar donated represents a story, a life, and a meaningful impact made possible through generosity.

We are proud to report that the 2025 event achieved its highest net income to date: \$22,917.53.

Senior Services Levy

On November 4, the senior services levy appeared on the ballot for renewal. Given the current economic climate and the rising cost of providing essential services, it became necessary to request an increase in the annual disbursement. The proposal presented to voters was a 0.8-mill renewal accompanied by a 0.4-mill increase. In the months leading up to the election, our staff and Board of Directors dedicated countless hours to educating the community about our services and communicating the critical need for additional funding.

Securing the levy's passage was especially challenging in Ohio, where the use of property taxes to fund senior services, schools, local government, safety forces, and libraries has come under growing scrutiny. A statewide grassroots effort aimed at eliminating property-tax-based funding created additional hurdles for local levies across all sectors. Despite these obstacles, we are grateful that our community recognized the essential value of the services we provide and voted YES on November 4.

The newly approved levy will take effect on January 1, 2027, ensuring continued support for the seniors who rely on our programs every day.



Hall of Fame & Robert E. Hall Above & Beyond Award

The annual Virginia Kane Hall of Fame Award was presented to Bob Hall, recognizing his more than 25 years of dedicated service to the senior centers throughout Tuscarawas County. Bob has been an integral part of the organization, serving in multiple leadership roles on the Board of Directors and contributing significantly through his work on the Building Committee. His tireless commitment and steadfast support have played a vital role in our continued success.

The Robert E. Hall Award was presented to Peggy Robb, who retired from the senior center in 2024. Throughout her tenure, Peggy consistently exceeded expectations, demonstrating exceptional dedication to the seniors she served. Her compassion, professionalism, and unwavering commitment have left a lasting impact on our organization and community.

Congregate Nutrition

The cost of daily lunch remains \$5.00 per meal for dine-in and \$6.00 for take-out orders. While the actual cost of each meal ranges from \$10 to \$15, levy funds help subsidize the majority of expenses to keep meals affordable for our guests aged 50 and over. In 2025, a total of 34,003 meals were served, reflecting a decrease from 2024. As our population continues to age, we are observing a shift in preferences: fewer seniors are participating in congregate dining, while more are choosing the café environment. This trend highlights an evolution in what older adults consider essential to their daily routines. Prospect Perks Coffee & Cafe

Prospect Perks Coffee & Café continues to be a favorite destination for seniors to enjoy breakfast, lunch, or a cup of coffee. It has become a natural gathering place for our fitness members, who often celebrate their achievements with a coffee while socializing with friends. The café menu offers a wide variety of lunch options, including fresh salads and what many consider the best burgers in town. 
Catering/Rentals

Fund Development

The Fund Development Department remained active throughout the year, coordinating extended travel, day trips, fundraising events, community engagements, marketing, and outreach initiatives. In 2025, the department offered three extended trips—to the Western Caribbean, Lancaster, and New York City—and organized eight-day trips enjoyed by travelers. Combined revenue from extended and day trips totaled \$63,454, representing a 28% increase over 2024. The department also continued to host the monthly Ladies Having Fun luncheon for members.

In addition to travel programming, the Fund Development Department is responsible for generating revenue to support capital expenses not covered by levy funds. In 2025, two major fundraising events—12 Days of Christmas in July and Forks, Corks & Comedy—together produced \$29,133.47 in net profits, marking a 42% increase from the previous year. The 3rd Annual Forks, Corks & Comedy event was especially successful, drawing 16 event sponsors and achieving its highest net profit to date at \$22,917.53.

2025 was the first year that the Tuscarawas County Senior Center participated in the Giving Tuesday event. This is a global event that encourages others to donate their time, talent and treasures to a nonprofit organization on the first Tuesday of December. We received \$13,000 in our first year of participation.

In 2025, the organization launched an updated and fully redesigned website. The new site provides a comprehensive overview of TCSC's programs, services, and resources, making it easier for community members to find the information they need. The enhanced layout, improved navigation, and updated content ensure that visitors can quickly access details about what TCSC offers and stay connected with upcoming events and opportunities.

Senior Services Network

As part of this department, the Senior Services Network (SSN) includes representation from local nursing homes, hospice providers, and healthcare organizations. SSN is dedicated to increasing awareness of senior services within the community and providing valuable outreach to our aging population. The committee focuses its efforts on equipping caregivers and older adults with information about available programs, services, and access to essential resources. In 2025, SSN facilitated two major community events: the annual Picnic in the Park and the Hall of Fame Gala. The Senior Service Network sponsored pop-up markets to senior living communities and Senior day at The Tuscarawas County Farmer's Market.

In-Home Services


In Home Services provides senior helpers who support older adults within their homes. This program plays a vital role in enabling seniors to remain independent by offering assistance with household chores, meal preparation, and other tasks they may no longer be able to manage on their own. Additionally, the service ensures that seniors can obtain groceries and prescription medications when they are unable—or find it difficult—to leave their homes. Through this support, In Home Services helps maintain safety, dignity, and quality of life for our aging population.

2025, we served 135 clients with 2739 hours of services and 1558 number of visits. The program billed \$34,913.13 for services rendered by seven (7) Senior Helpers; Nancy Burgan, Rebecca Everhart, Carol Green, Mary Jo Jones, Gale Limron, Anna Porter and Drema Porter.

Minor Home Repair

This program remains essential to supporting seniors in their efforts to live safely and independently. Our repairmen are skilled in constructing handicap-accessible ramps, performing minor plumbing and electrical repairs, and assessing homes for safety concerns that require attention.

In 2025, the team completed 61 service jobs, including the construction of 11 ramps totaling 451 linear feet. The program collected \$10,694 in client contributions and utilized \$40,894 in levy funds. All services were provided by our three dedicated repairmen: Mark Conrad, Dan Ryan, and Larry Carlin.



Supporting Our Seniors

The SOS program assists those over age 50 who were struggling financially either due to illness or job loss. Unfortunately, we were unable to support at the same level as 2024 due to lack of funding. SOS served 13 individuals for a total of \$4191.94.



2025 marked the sixth year of this program at the Tuscarawas County Senior Center. The program employs three full-time Community Health Workers who maintain caseloads of individuals, families, seniors, and pregnant mothers residing throughout Tuscarawas County. In addition, the program provides focused support for chronic disease management among adults age 50 and older through group sessions, one-on-one consultations, and assistance related to social determinants of health.

Annualized data indicates that program income continues to grow each year. In 2025, program revenue reached \$168,060.75, compared to \$133,740.19 in 2024—a 20% increase. The program operates without levy support and is fully sustained through grant funding and Medicaid reimbursements. Net income for 2025 totaled \$63,595.56, representing a 56% increase in program profits.

Medicare Consultations

Carla Mayfield serves as our OSHIIP-trained Medicare Consultant. She provides personalized support to older adults by answering Medicare-related questions and offering one-on-one guidance. Consultations are available both by phone and in person, ensuring seniors receive clear, accurate, and accessible information to make informed healthcare decisions. In 2025, she assisted 455 seniors throughout the year with ongoing consultations and during Medicare Open Enrollment, resulting in a total savings of \$352,605 for Tuscarawas County residents.

Transportation

The program is supported through grant funding from the Ohio Department of Transportation, the Area Agency on Aging, the Older Americans Act, and local levy funds.

Our daytime hours of operation are Monday through Friday, 8:00 a.m. to 4:00 p.m.

In 2025, a total of 365,452 miles were traveled in Tuscarawas County to provide transportation for 958 unduplicated individuals—an increase of 7% from 2024.

In 2025, the organization operated its largest fleet to date, with 26 vans, and maintained at least 19 vehicles on the road daily to meet community needs. The transportation program is supported by 28 trained and fully vetted drivers, all of whom meet the requirements associated with providing safe and reliable service.

Transportation services are provided free of charge to any Tuscarawas County resident aged 60 or older.




The Activities Department oversees all in-house programming, including recreational activities and fitness offerings. Our ongoing partnership with the Dover Public Library (DPL) continues to enhance member engagement by providing a part-time librarian who organizes the book collection, leads monthly travel programs, and offers members access to technology rentals through the library.

A variety of in-house activities—such as Bible Study, pool, puzzles, card tournaments, and games—continue to draw strong participation. For the second consecutive year, a dedicated volunteer group has partnered with a missions organization to sew clothing for boys and girls in need around the world. This group, consisting of approximately 10 volunteers, meets every Tuesday and generously donates their time and talent to support this meaningful outreach. Holiday parties remain a highlight of the year, consistently well attended and enjoyed by members. Each celebration features interactive games, plenty of laughter, and delicious desserts.

Lunch and Learn programs have expanded to several days per week, featuring informative presentations from organizations such as Hennis, Aultman Hospital, Cleveland Clinic Union Hospital, the Men's Group, the Tuscarawas County Health Department, and others.


In addition, the Activities Department continues to host dances, health screenings, and performances by the Forever Young Singers, ensuring a wide range of enriching opportunities for members.

The VIP Fitness Program continues to experience steady growth, particularly among adults ages 50–65. In 2025, Pop-Up Fitness offerings remained an effective way to reintroduce popular classes and generate renewed excitement and engagement among VIP members.

Virtual fitness options, including GeriFit and Yoga, continue to be available and well utilized. At the same time, in-person class participation has increased due to the addition of more volunteer and contracted instructors. TCSC remains committed to meeting the needs of the “50 North” population by offering a diverse fitness lineup that accommodates varying interests and ability levels.

In 2025, VIP memberships remained at \$55.00 annually, and participation continued to grow. The program recorded 861 VIP memberships, representing an 18% increase from 2024.

Social memberships, priced at \$25.00 annually, also experienced strong growth. A total of 1,287 Social memberships were recorded in 2025—an 18% increase over the previous year.



Vision and Direction for 2026
